Ensure that you have advised the pharmacist you are rostered with when you have to attend the intern meeting

OTC tutorials are usually scheduled for 9:45am on Wednesdays, some days swap to ensure attendance from all 3 interns

OTC & Primary Care Tutorials are prepared by and delivered by interns, with a pharmacist facilitator (preceptor or delegate)

Each week the tutorial presentation should include a summary of:

The condition/s, how it presents (signs/symptoms)

Differential diagnoses, what else it could be, or other conditions with similar symptoms

Warning symptoms/signs (red flags) and when to refer, special population considerations (eg in pregnancy/lactation, in children, in elderly, in patients with "x" medical condition)

Recommendation of suitable range of OTC products or treatments suitable for the condition

Description of relevant products/treatments, how they are used, counselling/warnings

Also consider a product that you would NOT recommend in the condition, and why not?

To wrap up your presentation, spend the last 5 minutes guiding your colleagues through a scenario, ie a person enters your pharmacy and asks for a product or advice...

how would you make sure what they want is safe & appropriate and what alternative approach would you recommend if you think it's inappropriate?

Aim for your powerpoint presentation in total to be around 30 minutes, plus 10-15 minutes for discussion & questions. (IFP Domain 5)
